INSTRUCTION NOTE 23 - PREVENTION AND MANAGEMENT

OF CORONAVIRUS (COVID-19) - OPENING OF SCHOOLS ON

1 JUNE 2020

- This Instruction must be read in conjunction with all instructions previously issued in this regard, Regulations in terms of the Disaster Management Act published on 29 April 2020 and 28 May 2020, the Health and Safety Measures in Workplaces published on 29 April 2020, and the Directions by the Minister of Basic Education published on 29 May 2020 and the amendment to the Directions published on 1 June 2020. See attached amendment.
- 2. Instructions 17 and 18 are hereby amended as far as it conflicts with this instruction.

#### **OPENING OF THE SCHOOLS**

3. The following Directions by the Minister of Basic Education are specifically brough to your attention:

# **OPENING OF SCHOOLS**

Direction 4(2)

Only those schools and offices that have complied with the minimum health, safety and social distancing measures on COVID-19, as contemplated in these

Directions and the Regulations, will be allowed to open as contemplated in in subdirection (1). (as amended).

# **OPENING OF AFTERCARE CENTRES**

# Direction 4(2A)

Aftercare facilities that are associated with schools, including aftercare facilities in education support centres, are allowed to re-open with schools, as contemplated in subdirection (1): Provided that they comply with the minimum health, safety and social distancing measures and requirements on COVID-19, as referred to in the Directions and the Regulations."

# SCHOOLS THAT CANNOT OPEN

## Direction 4(3)

A school or office that has failed to comply with the minimum health, safety and social distancing measures on COVID-19, as contemplated in these Directions and the Regulations, will remain closed until all the health, safety and social distancing measures are in place.

#### Direction 4(3A)

The education department must make arrangements with a school as contemplated in subdirection (3), fo learners to receive ongoing teaching and learning to ensure that education continues in accordance with the curriculum and that a learner is not disadvantaged by the school not re-opening.

#### 4. Therefore:

4.1. Where schools have received PPE's for SMT,s, or have their own PPE's, and are compliant with health and safety measure, such SMT's must report to school on 1 June 2020, or as soon thereafter as possible, and continue to prepare the school for the return of educators and learners, and continue managing remote teaching and learning.

- 4.2. Where schools have received PPE's for SMT's and educators, or have their own PPE's, and are compliant with health and safety measure, SMT's and all educators must return to school on 1 June 2020, or as soon thereafter as possible, and continue to prepare the school for the return of the learners and continue managing remote teaching and learning.
- Grade 7 and Grade 12 are expected to return to school on 8 June 2020
- 5. Principals and SMT's are expected to ensure that School Support Teams:
  - 5.1. Are trained on how to assist in maintaining health and safety and social distancing measures.
  - 5.2. Are trained to do screening.
  - 5.3. Assist in the general preparation of the schools for the receiving of learners.
- All educators and school based non-educators who must report to school according to either par 4.1 or par 4.2, must remain at their workstation for the required minimum hours per day.
- 7. Further guidelines for the return of certain officials specifically referred to in the regulations will follow:
  - Regulation 5(5)(d) Employees with known or disclosed health issues; and
  - 7.2. Regulation 5(5)(e) Employees above the age of 60 years.
- 8. Educators and school based non-teaching staff who are:
  - 8.1. 60 years and older with at least one comorbidity, or;
  - other educators and school based non-teaching staff with more than one comorbidity,

are urged to work from home until the final guidelines have been issued.

 Principals, SMT's and SGB's are urged to establish and maintain good communication channels with all parents, learners and the wider school community. 10. District Directors are hereby instructed to ensure that this communication reaches all officials and public schools immediately.

AMENDMENT OF DIRECTIONS ISSUED IN TERMS OF REGULATION 4(3) OF THE REGULATIONS MADE UNDER SECTION 27(2) OF THE DISASTER MANAGEMENT ACT, 2002 (ACT NO. 57 OF 2002) REGARDING THE RE-OPENING OF SCHOOLS AND MEASURES TO ADDRESS, PREVENT AND COMBAT THE SPREAD OF COVID-19 IN THE NATIONAL DEPARTMENT OF BASIC EDUCATION, ALL PROVINCIAL EDUCATION DEPARTMENTS, ALL EDUCATION DISTRICT OFFICES AND ALL SCHOOLS IN THE REPUBLIC OF SOUTH AFRICA

I, Angelina Matsie Motshekga, Minister of Basic Education, in terms of regulation 4(3) of the Regulations made under section 27(2) of the Disaster Management Act, 2002 (Act No. 57 of 2002), as published under Government Notice No. R.480, in Government *Gazette* No. 43258 of 29 April 2020, as amended by the Regulations published under Government Notice No. R.608, in Government *Gazette* No. 43364 of 28 May 2020, hereby issue the directions in the Schedule.

#### SCHEDULE

### **Definitions**

1. In this Schedule, the "Directions" means the Directions regarding the re-opening of schools and measures to address, prevent and combat the spread of COVID-19 in the Department of Basic Education, all provincial education departments, all education district offices and all schools in the Republic of South Africa, as published under Government Notice No. 302, in Government *Gazette* No. 43372 of 29 May 2020.

#### Amendment of direction 1 of Directions

2. Direction 1 of the Directions is hereby amended by the insertion after "Disaster Management Act" of the following definition:

""ECD" means a learner in Grade R or lower in a school;".

#### Amendment of direction 4 of Directions

- 3. Direction 4 of the Directions is hereby amended—
  - (a) by the substitution for subdirection (1) of the following subdirection:
    - "(1) The phased in return of learners, educators and officials to school will be as follows:

- (b) by the insertion after subdirection (1) of the following subdirections:
  - "(1A) A school may be permitted to deviate from the phased in return to school in respect of specific Grades or dates, as contemplated in subdirection (1): Provided that such school—
    - (a) complies with the minimum health, safety and social distancing measures and requirements on COVID-19, referred to in the Directions and the Regulations; and

- (b) applies prior to implementing such deviation, on a form that substantially corresponds with Annexure B, to the Head of Department responsible for education in a province, for approval of such deviation.
- (1B) The Minister, head of department or a delegated official or institution reserves the right to monitor compliance with the conditions set for the re-opening and management of schools.";
- (c) by the insertion after subdirection (2) of the following subdirection:
  - "(2A) Aftercare facilities that are associated with schools, including aftercare facilities in education support centres, are allowed to re-open with schools, as contemplated in subdirection (1): Provided that they comply with the minimum health, safety and social distancing measures and requirements on COVID-19, referred to in the Directions and the Regulations."; and
- (d) by the insertion after subdirection (3) of the following subdirection:
  - "(3A) The education department must make arrangements with a school as contemplated in subdirection (3), for learners to receive ongoing teaching and learning to ensure that education continues in accordance with the curriculum and that a learner is not disadvantaged by the school not re-opening."

#### Amendment of direction 10 of Directions

- 4. Direction 10 of the Directions is hereby amended—
  - (a) by the substitution for subdirection (4), of the following subdirection:

- "(4) Schools with large enough facilities to comply with health, safety, and social distancing requirements—
  - (a) are exempted from subdirection (2); and
  - (b) do not have to change their traditional and daily timetable models, and may continue to operate in accordance with those timetable models:

Provided that they continue to ensure compliance with the minimum health, safety, and social distancing measures and requirements on COVID-19 as set out in the Directions and the Regulations."; and

(b) by the deletion of subdirections (5) and (6).".

# Commencement
