BACKGROUND

The Eastern Cape Department of Education (ECDOE) operates an excessively high number of schools, distributed disproportionately throughout its twelve (12) newly established education district with 5 279 operational service sites accommodating over 1,872m learners. A huge number of these schools fall within the classification of being 'small and unviable' with learner enrolment below 135 for Primary schools and 200 for Secondary school riddled with multi-grade teaching and consequently poor-quality education offered. The ECDoE has since 2012, embarked on a process of rationalising the small and unviable schools as well as the realignment of schools to the correct prototypes as part of the process to reform the institutional landscape of education in the province. A baseline determined in 2016 identified 1 902 school as small and unviable for quality education delivery and attainment of quality educational outcomes.

The main objective of the School Rationalisation and Realignment Program (SRRP) is to promote existence of larger and better resourced schools and to ensure that they become centres of excellence where learners are encouraged to learn, and teachers are able to effectively deliver education services. The Rationalisation and Realignment Programme moves from the premise that the quality of education outcomes is achievable or realisable through education planning hence, the program is not about the closure of schools, but rather improving teaching and learning outcomes.

The following articulates strategic intent of the SRRP:

- Improved learner outcomes and the provision of high-quality education through elimination of multi-grade teaching and creation of viable schools within approved prototype.
- Redirecting resources to desired outcomes to enable the department to provide adequate basic services to schools,
- Creating conditions for effective school management and performance through school size management,
- Strengthening the Monitoring and Evaluation functions and performance management through school landscape management (CSLP Circuit School Landscape Plans),
- Strengthening the capacity and functionality of schools leading to a larger base of selfmanaging schools.

A Summit on Rationalisation and Realignment of Schools (SRRP) was mooted in the 2018 DEF Induction Session, where SRRP was amongst topical issues around the advancement of education transformation, within the ambit of the District Education Forum (DEF). A District Education Forum (DEF) is a representative body of all key stakeholder groups interested in improving and enhancing the quality of education outcomes. Its mandate, roles and responsibilities are defined in the DEF Constitution of 2014, which include amongst others, serving as a voice for all stakeholders, and providing advisory support for effective implementation of education programs including SRRP. The provision of good-quality public education is not an exclusive responsibility of the Department of Education because education is a replication of a social system and as such should be treated as a societal matter, hence a summit becomes an appropriate platform.

- The Rationalisation and Realignment Programme (SRRP) by design requires both intra- and inter-stakeholder engagements for effective implementation. All facets of stakeholder interaction have not been efficiently managed from programme inception, (2012 to date) and continue to present challenges for the sector.
- Pursuant to the above realization, DBE has in 2021, introduced SRRP Terms Of Reference (ToR) which provide guidance to provinces on the strengthening of SRRP governance structures; *viz*: Project Committee and Project Steering Committee composition, with the latter including relevant government Departments.
- The participation of Chief Directorates in the SRRP coordination as well as the execution of their respective roles and responsibilities has not been optimal, owing to different interpretation of roles in the SRRP.

It then becomes logical that any stakeholder interaction at this conjuncture needs to enrich an understanding of roles and responsibilities within the Dept of Education and across state departments and broader stakeholder fora. These are built within the ambit of SRRP implementing structures.

Since 2018, the SRRP has delivered on the following milestones:

- a) Development and adoption of SRRP Implementation Plans and Tools; Circuit School Landscape Plans – (CSLPs, ecsrp webmap, subsidiary Plans; Infrastructure, Scholar Transport and Hostel Plans in support of Rationalisation and Realignment),
- b) 2019 Target setting which focused on one and two Teacher schools which culminated in 2021 publication in a Government Gazette,
- c) Clearing SRRP Backlogs dating back to 2012, through the publication of One Thousand, One

hundred and forty-two (1 142) closed schools since 2012 to 2020, 16% of which fall outside the 2016 baseline.

d) Upon completion of all administrative processes on the 1 142 schools, which include amongst others, the repurposing plans and decanting of buildings, a new Custer of SRRP Candidate Schools shall be identified for the next three-year cycle. That will include paying attention to schools, which although below the minimum threshold, have been recommended for retention, expansion and conversion with attendant resource implications as provided for in the policy framework for the SRRP.
