INSTRUCTION TO THE APPLICANTS IN THE FILLING OF CLOSED POST LEVEL ONE BULLETIN FOR SCHOOL-BASED EDUCATORS

#### **BACKGROUND**

The vacancies advertised in this circular are as a result of natural attrition and in increase in post allocation in terms of the 2018 Educator Post Establishment (PPN).

#### 2. GENERAL PRINCIPLES

- 2.1 This instruction is developed within the framework of the Personnel Administrative Measures (PAM) and relevant ELRC Collective Agreements. In this regard the following general principles must be noted:
  - 2.1.1 The obligation of the state as the Employer in terms of Section 195 and 197 of the Constitution of the Republic of South Africa which includes the following factors:
    - The ability of candidates
    - The need to redress the balances of the past to achieve broad representation.
- 2.1.2 The obligation of the Employer in terms of Section 189 of the Labour Relations Act, 1995 as amended and other applicable labour legislations.
- 2.1.3 The obligation of the Employer to achieve equality in the workplace in accordance with the provision of the Employment Equity Act (EEA) of 1998 as amended.

- 2.1.4 The role of the governing bodies, in terms of section 20(1)(i) of the South African Schools Act as well as chapter 3 of the Employment of Educators Act, 1998 as amended. These provisions require school governing bodies to accommodate the obligations of the employer towards serving educators.
- 2.1.5 The requirements for the filling of educator posts as encapsulated in Chapter B of the PAM.
- 2.1.6 The powers of the Head of Department as contained in Section 6 of EEA and PAM Chapter B.

Educators declared as additional must attached their letters declaring them additional.
